PRIVACY NOTICE

We, Thai Wah Public Company Limited (the “**Company**”), need to collect, use, disclose, transfer and process your following general personal data (“**General Personal Data**”) and sensitive personal data (“**Sensitive Personal Data**”) (collectively referred to as “**Personal Data**”).

Purposes of Personal Data processing

Your Personal Data will only be collected, used, disclosed, transferred and processed to the extent necessary for the purposes of:

Impact if the Company doesn’t receive your Personal Data

Without the Personal Data requested above, the Company will not be able to achieve the above-mentioned purposes.

Disclosure or transfer to third parties

The Company will keep your Personal Data with strict confidentiality and will not disclose or transfer it to any third parties unless the Company has the express consent from you, or specific instructions from competent officials.

For the above purposes, the Company may disclose or transfer your Personal Data to third parties including:

- Group companies or affiliated companies of Thai Wah Public Company Limited
- Service providers, vendors or business partners

In the case where the Personal Data will be transferred outside Thailand, the Company will comply with the Personal Data Protection Act, B.E. 2562 (“**PDPA**”) including but not limited to ministerial regulations, notifications, interpretations or other regulations issued under such Act.

Retention period

The Company will retain your Personal Data for a period of 3 years after your relationship with us has ended and will destroy it immediately once the retention period has elapsed. The Company undertakes that your Personal Data will be retained in a secure location, accessible only to authorised persons.
